The neighborhood had our chance to meet our new City Manager, David Cavazos, and our new Chief of Police, Carlos Rojas, at our October 9th General Meeting at Wilson School. David and Carlos tag teamed with a short presentation about the state and future of the City then opened it up to questions for both of them. They have been working hard to create change for the better and are making progress. There are some new grant monies available to add personnel to the SAPD as wsell as focus on improving other areas of the city. Clearly they envision a safe Santa Ana we want to be proud to say we live here.

A committee has been formed to look out for our property interests after the "double-wide" manufactured home was moved into the neighborhood this summer and the pending development at the property above 15th St. at Olive and Lowell. The committee has had a couple of meetings with the city planning and building officials to insure proper development at this new location to lessen the impact to our property values. This is ongoing project and you can read the response letter from the city on page six.

Another committee is currently working with the city to enhance our entry planter beds at Olive/Washington and Louise/Washington to show the pride we all have to make Washington Square a unique and involved neighborhood. We are partnering with the City to share the expense to spruce up our entry beds to a more pleasant appearance as you enter into Washington Square. Keep your eye out!

Recently code enforcement conducted a "sweep" of Washington Square, as they have in the past years, and there were 90 some infractions sited. Most were minor infractions such as trash barrels left out in view between trash days, unkept lawns, parked cars on lawns, Christmas lights still up, and debris in the driveways or front yards. Some of the more egregious infractions were non-landscaped front yards, dead grass, inoperable and improper vehicles (boats, RV's, in-op vehicles) in the driveway, non-maintained homes with pealing and/or lacking paint, roof repairs, and broken windows. It might be time to walk across the street and take a look at YOUR house and see if it matches up to the one you look at from your house, or set an example for that neighbor by showing pride in your home. These infractions are a misdemeanor and come with a \$100.00 citation if not corrected within 30 days. We don't want that!

On a brighter note the Third Annual Oktoberfest is coming up on Oct. 18th. This has become as much of a popular event as our Wine Walk. I don't know why, other than maybe beer is involved?? The event will again be serving craft beers, large pretzels, bratwurst and sauerkraut as well as many raffle prizes. We will have the Oktoberfest DJ with all the polka, costume apparel, and chicken dance music to dance by. And with that said........

The Alan Anderson Award is presented to residents of a selected Washington Square home that exemplifies Alan's love, pride and care for his home, neighbors and neighborhood was legendary. His dedication and spirit contributed to Washington Square's sense of community, pride and positivity.



Years ago when Gloria Chavez started working at the courthouse, parking was practically impossible. So to avoid the hassle, she parked at her parent's nearby home and walked through Washington Square to get to work. One day she noticed a cute little house for sale. Her realtor friend had a lockbox key so they went to look at it. Although it was in rough shape at the time. she had a vision for the future.

Gloria is only the second owner of the 1922 house, and with the help of a talented family started making improvements immediately after moving in. Many of the custom touches and her beautiful new wooden windows are thanks to the generosity and talent of her father and brother. Born in New Mexico and possesed of a growing colletion of artifacts, Gloria committed to the Southwest style early on. It's been 15 years and now her home is a showplace.

Fusarium Wilt of Mimosa Trees is Killing

Pretty Mimosa Trees are prized for their spring flowers and lacy foliage. They are popular here in Washington Square but a couple have suddenly died recently and Susan van der Roest and the Tree Committee suggest we learn about the cause of their deaths.

No matter what you call it: Fusarium Wilt, Mimosa Sudden Death, Mimosa Tree Disease; it's always fatal to the tree and there's just no stopping it.

Unfortunately, there are no controls. However, most other tree species are not susceptible to the fungus which lives in the soil, so replacing diseased mimosa with a non-susceptible host tree is the best option because the soil will be contaniminated for about two years after the tree is removed.

Fusarium wilt is caused by the fungus Fusarium oxysporum forma specialis perniciosum. This mouthful colonizes and clogs the tree's vascular (water-conducting) tissue, resulting in relatively rapid tree death. Because the tree dies from the insisde out, by the time syptoms are obvious, it is too late. It is always recommended that the tree be removed.

Symptoms: Generally, the first readily noticeable symptoms of mimosa wilt are yellowed, stunted, and wilted leaves on one or several branches in early to mid-summer. Later in the summer the affected branches may prematurely defoliate. Yellowed and wilted leaves continue to appear on more branches throughout the summer and fall, although in some cases a tree may die within a month of initial symptom appearance. As the disease progresses, cracks begin to appear in the bark. In some cases, gum or a white, frothy liquid with a fermented odor may exude from cracks. Sometimes a tree survives to the next growing season, but the new leaves will be stunted and yellowed and the tree will continue on a relatively rapid decline toward death. After the aboveground portion of the tree dies, roots may still be alive and shoots may continue to sprout from the base of the trunk for some time.

Controversial New Development Planned in the Square

Property on North Olive/Lowell. Developers rumored to be installing manufactured homes.

Following is the text of a letter to President Tom Lutz from Acting Planning Manager, Vince Fregoso, regarding the planned development of possibly six homes on the empty, cleared lot adjacent to north Lowell and Olive. He is addressing the concerns of the neighborhood to factory built homes which can lower property values in the neighborhood. The letter was sent pursuant to a meeting wiith board members and City Staff.

This letter is in response to your correspondence dated August 20, 2014 that discussed the infill housing project under construction at 1108 North Baker Street as well as questions regarding residential development.

The Washington Square Neighborhood is a key neighborhood in the City that is known for both its civic activity as well as the number of properties designated to the Santa Ana Register of Historical Properties. However, unlike French Park, it has not been designated as a local, state or federal historic district. Regardless of its designation, the neighborhood is still historically significant, with careful review of new and renovation projects given to ensure that the Zoning Ordinance and Citywide Design Guidelines are adhered to. Staff review is intended to ensure that historically designated structures meet the Secretary of the Interior's Standards for Rehabilitation. Further, the review of renovation projects that involve large additions or major architectural changes are assigned to Hally Soboleske due to her familiarity with the neighborhood and the applicable design standards.

Manufactured (factory built) housing can be built to meet affordable housing requirements. However, there is no requirement that these types of structures be built specifically as affordable housing. For example, the residence at 1108 North Baker Street was not built as affordable housing and does not have any affordable covenants and/or restrictions placed on the property.

Manufactured Housing is the term for what is generally referred to as a mobile home. This type of unit does not have a permanent foundation and could be moved without disassembly of the unit. The state is responsible for regulating and inspecting these units. This product type is only permitted in mobile home parks. Modular Housing, also known as Factory-Built Housing, is the same product for purposes of compliance with zoning and design standards. For purposes of consistency, the house at 11 08 North Baker is considered factory-built housing, and the City treats it just as we would any other house in terms of zoning/design compliance.

Factory built housing is distinguished from manufactured housing in state regulations (California Health and Safety Code, Div. 13, Part 6. Section 19960, et seq). This law is applicable to all cities in California and requires that local authorities treat factory built housing the same as standard wood-framed construction as a land use, which prevents the City from prohibiting them from being constructed. A valuable resource for local jurisdictions is from the State of California Housing and Community Development Department and can be found at http://www.hcd.ca.gov/codes/fbh/fbh-bklt.pdf. Be advised that cities retain the ability to review the architectural appeal and aesthetics of any factory built house, with the City utilizing the City Council adopted Citywide Design Guidelines. And, since the state requires cities to allow factory built housing, we do not have the ability to adopt a moratorium to prohibit their construction.

The appeal of a factory built house is that the mass production methods used for their construction makes them more affordable to construct than the standard stick built construction. The State views these structures as a way to allow more "affordable housing" to be built. The affordability factor is not because the selling price will be more modest or rent-controlled once complete; it is offering a way to construct residences in an affordable way thereby allowing a potentially more affordable residence.

At the time of this letter, the City has had preliminary discussions with the property owner and architect regarding properties on Olive/Lowell Streets above 151h Street. As this project will require the approval of a parcel/tract map to allow the subdivision of the property into several lots, a public hearing will be required. Please be aware that Washington Square will be notified in advance of any hearing for the development. And, staff has informed the property owner that conventional stick built housing is the preferred construction method for these units.

We have always been proud of our relationship with the Washington Square Neighborhood, just as we are proud of the neighborhood itself, and we desire to maintain a positive and open dialog with the neighborhood. 

End the silence on domestic violence!



Domestic violence is a silent epidemic in America. Every 15 seconds a woman is abused in America. It is the most underreported phenomenon in our society. Domestic violence and abuse can happen to anyone, in any neighborhood, yet the problem is often overlooked, excused, or denied. Nearly half of abusers re-offend, most within the first six months.

Noticing and acknowledging the signs of an abusive relationship is the first step to ending it. No one should live in fear of the person they love. If you recognize yourself or someone you know in the following warning signs and descriptions of abuse, reach out.

Domestic violence and abuse can happen to anyone, any where, any race. There are resources to help both the abused and abuser get better. There is hope. No one wants to teach their kids how to hate and hit (or worse) the ones they love. Our children need their parents and they are too precious to be raised in a violent environment.

A longtime advocate for women and children, Robin McGraw (Mrs. Dr. Phil) recently introduced The Aspire Initiative, an online help and emergency smartphone app to help women and teens in crisis. The potentially-lifesaving smartphone app, Aspire News, is available for free in the iTunes store, through Google Play and at www.whengeorgiasmiled.org. The app allows the user to create prewritten text or voice messages to be sent to designated numbers (911 or other chosen contacts)



with just the tap of a button. The ignition of the app's "go button" also starts a recording to capture the details of the domestic violence encounter or other dangerous event underway.

Aspire News is designed to appear like any other smart phone app to the untrained eye, allowing it to be downloaded and used in secret and safety. Combined with other resources, it is a tool to help end violence.

Do you suspect someone you know is in an abusive relationship? There are many resources, just google your concern and you will be provided with a wealth of information. Following are some "Do's and Don'ts" to help you help:

Do:

- Ask if something is wrong
- Express concern
- Listen and validate
- Offer help
- Support his or her decisions

Don't:

- Wait for him or her to come to you
- Judge or blame
- Pressure him or her
- Give advice
- Place conditions on your support

Big News! Tax Savings Available to WSNA Homes thru Mills Act

Want to save 40% or more on your property taxes? Your house may be eligible for Mills Act which bottom-line reduces your property tax bill significantly. Once your home is acknowledged as an Historic Property you can apply to take part in the Mills Act Program which is administered and implemented by local governments, in our case, the city of Santa Ana.

The Mills Act Contract encourages owners of historic properties to maintain the exterior of their properties by offering savings on property taxes. Owners of historic homes may qualify if they pledge to maintain the historical and architectural character of their properties, as well as obtain all required permits for any work performed.

Previously the cost to apply for the program was \$9000 but has been reduced to \$2011 for the next 12 months. The sooner you apply, the better.
