A Word from Keren Clark WSNA PRESIDENT

Dear Neighbors,

As we continue to slog through the COVID-19 pandemic, many of us find ourselves struggling with anxiety and depression. Even those of us who are faring tolerably well are likely dealing with sporadic on-going low levels of anxiety, sadness and depression.

It is important for all of us to remember how normal it is to not feel "normal". We are all grieving. If we are not grieving the loss of a loved one to the corona virus, we are all grieving the loss of life as we knew it before March 13th.

As a licensed and practicing psychotherapist, I am seeing the impact of the relentlessness of the conditions being created by the Covid-19 pandemic on my clients as well as on myself.

- I thought it might be useful in this particular President's letter to remind you of some of the impacts that a crisis time, such as the one we are currently living through, can have.
- Profound sadness, loneliness, emptiness, sporadic crying spells
- Fear about getting sick (for yourself or your loved ones)
- Insomnia or excessive sleeping
- Change in eating behaviors (eating less or more)
- Difficulty being with others
- Difficulty concentrating and retaining information; forgetfulness
- Short temper, irritability, or annoyance at others
- If you have lost a loved one you might experience: anger that the death oc-

Grants of up to \$10,000 for Businesses Affected by COVID-19

The Santa Ana CARES pandemic assistance program provides a variety of grants to help local businesses affected by COVID-19.

- The COVID-19 Small Business Incentive Program provides up to \$5,000 for Santa Ana businesses with 5 or fewer employees, including the owners.

Green Strip Maintenance

Maintenance of parkways, including, watering, mowing grass, trimming plants and weed removal is the responsibility of the property owner (except for City street trees). A parkway is the area between the curb and sidewalk and is a long planting strip sometimes referred to as sidewalk strip or parking strip. The parkway must be kept in a clean and neat condition and free from objectionable matter such as overgrown grass, weeds or obstacles, which may pose a hazard. In many areas of the City, the parkway is a City-owned right-of-way; however, the maintenance is still the responsibility of the property owner.

BROWN WASTE AND GREEN WASTE COLLECTION TOGETHER

You may have noticed recently that the trash truck is picking up both the green waste and the brown waste in the same truck. Sacramento has passed a law requiring that green waste be sent to separate compost sites, which would be an extra cost for Waste Management, and residents would be billed for the extra costs. Though the price was reasonable, Santa Ana city council voted not to pass it at this time, as they did not want to incur an added price to the residents during the COVID-19 pandemic. Thus, trash and green waste are going into the land fill together, which will help break down trash as the green waste decomposes and will reportedly help the longevity of our landfill. Eventually, though, Waste Management and the City will have to follow the new ordinance and we will see the increase on our water bill.

Gerald Carr: Did You Know?

When you say astronaut, those of us of a certain age often think of names like Aldrin, Armstrong or Cernan. Long time residents of Washington Square, however, may think of someone else: Gerald Carr. His last Washington Square residence was on North Louise, and his son Jeff was known to go door-to-door on Louise St. telling people that his father was an astronaut.

Carr was one of 19 astronauts selected by NASA in 1966. In 1973 Carr commanded Skylab 4 and was the first rookie to command a space mission since Neil Armstrong. Carr logged more than 34.5 million miles and circled the globe 1,214 times during his 84 days in space. He also was a key figure in the development of the lunar rover.

Although Gerald Carr was born in Denver, he was raised in Santa Ana which he considered home. He left Santa Ana for Houston in 1966. Carr received the NASA Distinguished Service Medal in 1974. Many residents may know already that Carr Middle School is named after our neighborhood hero and astronaut, Gerald Carr.

Carr died in August, 2020 at the age of 88.

curred, that your loved one “abandoned” you, at health-care institution/practitioner, at a deity or faith institution as well as guilt that you have survived.

Given the isolation of physical distancing and staying at home, we are all vulnerable. You might consider these self-care tips:

- Minimize watching, reading or listening to news that causes you to feel anxious or distressed. Seek information only from trusted sources.
- Avoid unhelpful coping strategies and substances, such as tobacco, alcohol, or drugs
- Be careful with “what if” thoughts. Manage your worst-case scenario thinking.
- Engage in personal self-care activities that bring joy (e.g., phone/virtual communication with friends and family, reading, listening to podcasts, watching comedy).
- Practice relaxation, meditation and self-expression via books, apps and online videos. Stay in the present. Take one day at a time.
- Utilize spiritual faith resources.
- Consider telehealth for mental health support.
- Eat sufficient and healthy food. Exercise when you can.
- Monitor yourself for prolonged sadness, difficulty sleeping, hopelessness.
- Remind yourself how you coped with past life challenges and enact those coping strategies today.
- Call 911 for any health emergencies or if you have thoughts of harming yourself or anyone else.

What's going on in and around DTSA? -- By Sam Puzzo

Covid-19 Advisory: Business operations may be affected. Due to ongoing precautionary measures, please contact the business directly for updated hours and availability.

Amid all our issues with the pandemic there is still a lot of activity in DTSA relating to food and the arts. The experiences may be just a little bit different!

DINING:

- One of the big stories is the planned closure of the Playground restaurant, which was a notable leader in the renewal of DTSA and fine dining. The Playground opened in 2011 when Chef Jason Quinn won the initial Great Food Truck Competition on Food TV. A recent news article reported that the Playground will likely close on Dec. 31, 2021, at the end of its lease. Chef Quinn has already closed Playground 2.0. He is reducing his restaurants to his 1.9 (ticketed tasting dinners) and Dough Exchange (fast casual takeout) concepts. The financial challenges of the COVID-19 era proved too great of an obstacle to continue all concepts.
- At 4th Street Market, many restaurants have resumed sales. The much awarded (by Michelin Dining) Burritos La Palma on Bristol has opened a location in 4th Street Market with a different menu from the original. Also, there is a new Loose Leaf Boba franchise, which lists coffee, tea, a juice bar and smoothies.



ARTS:

- You can't go visit the Orange County Center for Contemporary Art in-person just yet, but you can take a virtual 360 degree tour of their current show. You can "walk" through 32 views of the gallery with superimposed works by artists. The works are stunning, and the experience is a trip. Check it out!
- DTSA Open Stage is a cannot miss music and arts event that broadcasts performances from Downtown patios and plazas on the last Saturday of each month! You can watch online on Facebook or Youtube. Do you live in a historic home or a home with architectural significance? If so, your home may qualify for the Mills Act. The importance of the Mills Act is that your home will be put on the City of Santa Ana Register of Historical Properties, and there is an economic incentive in the form of reduced property taxes. The Mills Act was enacted in 1972, and the State of California says "The Mills Act is the single most important economic incentive program in California for the restoration and preservation of qualified historic buildings by private property owners." Once your house qualifies, you will be bound by a 10-year contract with the city to preserve, maintain, and restore the property as a historical property.

The 10-year contract is transferable to a new owner if you intend to sell the property. With property values going up, and therefore higher property taxes, this is a benefit to someone who is just purchasing the home and is looking at a huge property tax bill. If under the Mills Act, your property taxes are \$3000, then that would be a huge saving for someone who is purchasing a \$650,000 historical property and anticipating a \$7800 (appx) tax bill. This makes the home quite a bit more valuable to a buyer, and thus, as a seller, you most likely can sell it for more.

The application period for this year's consideration expired in August, but you can start thinking about and planning for next year. The current application fee is \$500 for the historical registry and \$2500 for the Mills Act application fee. If you want to consider applying, please contact me, and I will be happy to provide you with resources.
